



Day Care & Nursery Schools Have No Evacuation (67FR66588) Planning Requirements.

Currently day care centers and nursery schools are not federally required to have ANY radiological emergency evacuation plans.

Without new NRC requirements designed to insure all day care centers and nursery schools are properly planned for, children will continue to be left without any:

- designated relocation centers
- designated transportation
- approved-child-safety seats
- rosters of emergency bus drivers
- planned educational materials
- notification of state of readiness
- inclusion in radiological emergency preparedness exercises, etc.

Until the U.S. Nuclear Regulatory Commission creates new regulations requiring emergency planning for day care centers and nursery schools none will ever exist.

Current NRC and FEMA oversights clearly fail to meet FEMA requirements for offsite plans, and preparedness to adequately protect the public health and safety.

So please help us by signing this petition supporting our efforts to fix this dangerous oversight.
